Are you or someone you love eligible?

- 16 million Wartime Veterans and spouses are potentially eligible, including 9 million from Vietnam.
- Wartime Pension with Aid and Attendance benefit is paid for by the United States Department of Veterans Affairs.
- A recent VA report shows that only 1.63% of Veterans are collecting benefits.
- Most Vietnam, Korean and WWII Veterans and spouses do not know the Aid and Attendance benefit exists.
- Claimants applying for Veterans benefits may obtain free assistance in filing an application from VA recognized advocates for Veterans. No person or company, including Patriot Angels, can charge a fee to assist a claimant with the preparation, presentation, and prosecution of a claim.

*To qualify for pension benefits, claimants' countable income must not exceed annual pension limits that are set by statute. Such limits may vary based on whether the claimants are Veterans or survivors, as well as their family composition and medical expenses.
